Please note that in making application for membership of the Club you acknowledge and accept that you will be subject to the Australian Handicap System and your handicap may be reviewed in the absolute discretion of the Board of Directors on the basis of any cards returned in any competition.

The Board of Directors may from time to time approve the alteration of a member's handicap it, in its absolute discretion and having regard to all of the circumstances, including the member's results in any form of competition, it considers that the change is warranted under the handicap system which the club follows. The member shall have no right to make representation to the handicapper in relation to any proposed alteration of the member's handicap. The member shall have the right to make representation to the Board in relation to any proposed alteration to the member's handicap within seven (7) days of the date of a letter notifying the member of such a proposed alteration

All information supplied forms part of the acceptance of the candidate for membership, and if proven to be incorrect, membership of the Moss Vale Golf Club Ltd, may be suspended or terminated by the Board of Directors.

CADET MEMBERSHIP

Moss Vale Golf Club now offers a class of membership for Juniors under the age of 12 years old, however, the following restrictions apply:-

1. The Cadet Member when present at the Golf Club (on the course or in the Clubhouse) must be accompanied by a playing member of the Moss Vale Golf Club.
2. When playing on the course full consideration must be given to other golfers.
3. The Cadet Members may be entitled to play in open competitions if they can prove to the Match Committee that they have learnt the rules of golf, the requirements of etiquette and have the ability to play the game to an acceptable standard.
4. If the Cadet Member is granted a handicap, then they still only play in competition accompanied by a playing member who is prepared to take responsibility for their behavior.
5. An important part of being a member of our Golf Club is that we all must obey the rules of the Club and any failure to comply with those rules could see any member lose their rights of membership.
6. Supplied is a list of our present dress regulations, which all members are required to adhere to.
